A little later than normal on the weekend of 10<sup>th</sup> and 11<sup>th</sup> of June we held our Annual Banquet and this year we went back to Devonshire Place, Leicester, following a request from several members. Those that attended enjoyed a good choice of menu and silver service to the table. The food was excellent with everyone enjoying their choices. The Lord Lieutenant Michael Kapur OBE gave a speech which was very entertaining and informative. Unfortunately due to a throat condition Colonel Robert Martin was unable to make a speech on the night. Derek Austin of FEW, and Hazel Hague Master of York Guild made speeches.

The Freemen's church service and robed parade was held on Sunday 11<sup>th</sup> June at St Andrews Church, Aylestone and was led by the Rector Rowena. The readings were given by Sue Freeman and Jean Bates. Sadly Colonel Martin and Micheal Kappur were both unable to attend for personal reasons.

## Contributions to Gildhall News Glimpses of Ancient Leicester

I have recently had passed to me a book by a neighbour entitled 'Glimpses of Ancient Leicester' written by Mrs T. Fielding Johnson and first published in 1891. The book is neatly divided into six parts each describing the condition of Leicester during the following events during our history:

- Roman Leicester
- Leicester under the Anglo Saxons and Danes
- Leicester under the Norman and Plantagenet Earls
- Leicester in the Sixteenth Century
- The Siege of Leicester
- Leicester at the end of the Eighteenth Century


Quite recently I wrote a brief account of the Siege of Leicester and our contribution to the Civil War so I will not bore you with a second rendition of Leicester's war effort except to relate to you an incident that may be of interest. In 1645 there was stationed on the walls surrounding Leicester a young 16-year-old soldier by the name of John Bunyan providing sentinel duties with a comrade of his. Sadly, the comrade whilst providing cover for John Bunyan was killed on duty and the event so greatly affected him that he dates his conversion to religion from that event. There is no hard evidence to verify the incident but he was certainly stationed at Newport Pagnell as Private Bunyan and troupes from that garrison were billeted in Leicester during the siege.

It is in the last section that an item really captured my interest and that relates to the dispute between the corporation and the freemen. All of the members of the corporation were freemen, but not all freemen were members of the corporation, nor ever likely to be. In 1489 Henry VII withdrew the right of freemen to take part in voting for membership of the court, and for attending as observers at court meetings, instead introducing a self-electing court of 24 burgesses and a second tier of 48 comburgesses selected by the 24. This situation remained that way until 1835, at which time the council were no longer freemen but elected from the population at large.

The dispute began in 1755 when the corporation attempted to enclose the whole of the South Fields, an area of land conferred by Simon de Montfort in the 13<sup>th</sup> century upon the freemen of Leicester the exclusive privilege of pasture and arable farming. By enclosing the land by Act of Parliament the privilege

from time immemorial of the right of farming would be abolished. To aggravate the grievance of the freemen there was the suspicion that the council were granting leases to two aldermen who had used their influence to acquire the leases. In September of that year an angry crowd marched to the South Fields and destroyed all the fencing that had been erected to mark out the leases and made bonfire of the materials. There were also attacks on the properties of the town councillors with broken windows and damage to street paving. The corporation sought the advice of legal council but were advised that under the existing lease the freemen were within their rights to destroy the fencing.

At a Common Hall in 1757 the corporation ordered that the present leases enjoyed by the free-



men should be renewed as pasture for horses and cattle and the dispute came to an end. Parts of the South Field were enclosed and utilised for the benefit of the town residents; Gartree Road between the Horsefair and London Road was pedestrianised as the New Walk and an area that is now known as Victoria Park became a race course. To compensate for the loss of pasturage as parts of the South Field were sold, an Enclosure Act in 1804 allotted lands known as the Freemen's Common, Freemen's Meadows, and the Bull Piece to the Freemen as freehold property along with the management of the estate by freemen elected as a Board of Deputies.

#### A Freemen Remembered Edward John Yearby

Today there is a board in the Community Centre at Freemen's Holt titled "*List of Chairman of the Board of Deputies*" showing the names of all the Chairman (now known as "Chair") since 1899. The first name is that of Edward John Yearby (1856-1936) who was the Chairman in 1899. Edward was educated at Alderman Newton's which he knew in its Greencoat days. He left school in 1870 and was then apprenticed to H T and W Chambers – Builders & Contractors.

At the age of eighteen Edward was one of the young Tories who formed the

first committee of the first Conservative Working Men's Club. From that day he had been in the thick of practically every political fight in Leicester. It wasn't long before Edward set himself up to run his own business and went on to acquire substantial property and land in the City, County and Kettering.

He was married to Hagar Gertrude Blackwell, and they had seven children – Gertrude May, Grace Margaret, Dora Adelaide, Agnes Beatrice, Edward John, Frank Victor, Cyril Bagley. According to Wikipedia, Grace Road, Leicester is named after his daughter Grace and not W G Grace, the amateur cricketer who was widely considered to be one of England's greatest players.

On the 11 November 1916 the Leicester Mercury published "A Personal Sketch" of Edward, who had been a member of the Town Council for twenty five years at that time. It stated that:

"He did not find it all smooth sailing when he first entered the Town Council. His outspoken manner was not exactly relished by political opponents, and at times he carries his opposition even to the point of voting against his own party. He was never half hearted in his attitude towards any cause.

It is not unfitting to recall to the public mind a few facts in regard to his work on behalf of the ratepayers. Before the days of the "party truce" Edward John Yearby was rightly regarded as one of the most ardent fighters in the ranks of Leicester Unionists, and that after the war is over, he will fight again, and fight hard, no one can doubt. At the present time, when party strife is hushed, the other side of Alderman Yearby's character is to the forefront. Those who imagine he can only talk know little or nothing about him. True, he is a man with definite opinions, and is not shy in expressing them, whether what he says proves palatable or the reverse. But he is a man of business experience, willing and able to work many hours of every day. As Chairman of the Highways and Sewerage Committee he will have plenty of scope for work, and that he will take that work seriously is beyond doubt".

A memorial window was erected by Edward in memory of his three children – Dora Adelaide, Agnes Beatrice and Frank Victor. The memorial window was unveiled in 1928 by the Lord Mayor Alderman J Thomas and dedicated by the Rev. C E Jenkins, a former vicar of St Paul's who was residing in Brussels. The Leicester Mail reported that *"the subjects are exquisitely portrayed"*. The inscription across the foot of the panel reads *"To the Glory of God and the loving memory of these children of Hagar Gertrude and Edward John Yearby, Alderman of this City, this window is dedicated, A.D. 1928"*.

On the 30 September 1933 the Leicester Evening Mail reported that Edward had made a further gift of three stained glass windows to complete the Lady Chapel at St Paul's. The new windows are alongside the three other windows to the memory of his children. This gift was a memorial to his parents and a *"thank you offering"* for a long life. The windows portray Edward, King and Martyr, St John the Divine and King Edward the Confessor.

When Edward died at the age of 79 his will contained several bequests to charities as well as family members. These included:

- A trust for the upkeep and repair of the memorial windows and family graves.
- Music for the Choir at St Paul's

- The Leicester Royal Infirmary where he had been a life Governor
- The Leicester Blind Institution
- The Leicester Cripples Guild
- Leicester Deaf and Dumb Institution
- Lilian Castle Housekeeper
- Stanley Howard Chauffeur

Edward had been one of the oldest members of the Market Harborough Freemasons (St Peter's Lodge).

His sons all took their Freedom and below are a few facts about them:

#### Edward John Yearby (Junior) 1885–1938)

Edward was a carpenter/joiner in civilian life. He enlisted in the 2<sup>nd</sup> Battalion Leicester Regiment and by 12<sup>th</sup> December 1914 was in France.

#### Cyril Bagley 1898-1985

The 1911 Census shows Cyril as a Boarder at Bromyard Grammar School, Herefordshire. During the First World War Cyril he saw service as a Private in the Rifle Brigade (Prince Consort's Own). After the war he became a chemist and the 1939 Register shows Edward residing in Fulham. Cyril died at the age of 86 in Ventnor, Isle of Wight.

#### Frank Victor Yearby 1886-1917

Frank's civilian occupation was that of Fireman; he was based at the Fire Station in Rutland Street, Leicester. Lance Corporal Yearby, a gunner in the Royal Marine Light Infantry, was aboard the SS "Kingswood" when it was in collision with a French Vessel near Belle Isle on 15 March 1917. He drowned as a result of the collision and was the only man that died, and his body was not recovered for burial. His address was given as "Brentwood" 149 Narborough Road, Leicester.
