

Contributions to Gildhall News The Demise of the Gild

At the last Board Meeting held in September it was announced that the Gild was being terminated due to lack of interest, a decision that did not

come as a total surprise. Both Mick Ayres and I were extremely disappointed at the outcome; we are the only surviving members of the original court when the Gild was formed just a few months short of 50 years ago. I can almost hear our departed colleagues wailing at the news of the Gild's demise. Although we were forewarned of the impending announcement our immediate emotion was anger. Anger that the situation had been allowed to arise and who to blame. However, the blame game is pointless; it has happened, and the important thing is how to make a silk purse out of a sow's ear.

It is not the role of the Board of Deputies to organize social functions for the freemen at large; they are Trustees to the Estate and their activities are governed by an Act of Parliament. Which was why the Gild was formed 50 years ago. The Master of the Gild, Malcolm Ballard, has worked tirelessly to maintain some semblance of life in the Gild, but he is too ill to do much to relieve the situation. We are all getting older and though the mind is willing, the body somehow lets us down. The Gild Court desperately needed younger, more active volunteers, and though the Gild Court had asked for volunteers in the Gildhall News, none were forthcoming.

Will the phoenix arise from the ashes?

There is no reason why at some time in the future a group of freemen cannot revive the Gild, even if under a different set of rules. Without a Gild there is a danger that the freemen will return to the days of individuals all going their own way. Fifty years ago a group of enthusiastic freemen created the Gild and it was met with huge approval by many freemen from around the world. It was particularly well received by overseas freemen keeping up to date with news from home. As a means of uniting freemen the Court organised outings, some so popular they required two coaches, social functions usually involving food and drink and entertaining speakers.

All the records of the past fifty years are stored in the archives and will be boxed for future reference if required by an upcoming Gild Court. As will be all the past copies of the Gildhall News from the very first issue to the present day. It is worth noting that the Board have no obligation to continue with the quarterly journal.

I wish the best of luck to any future aspiring Gild Court, in whatever format you choose.

The Lime Tree Blues

Now here is a scene in Aylestone that does not bear much resemblance to today's outlook, only St Andrew's Church and the houses with the white stucco on the opposite side of Middleton Street are the same. Obscuring the view of the church from the camera is a tall lime tree which, sadly, is no more. This photograph, taken in 1958, shows the grandeur of the Holt, whose foundations still lie in the ground below the allotments on Freemen's Holt, much to the annoyance of some of the allotment holders.

But of the sadly departed lime tree there lies a tale.

Adam, the estate manager, was out inspecting the grounds and while standing beside the lime tree heard a loud creaking sound, and turning to look for the source of the noise spied a large vertical split. His immediate thought was that this isn't very safe, so he contacted the grounds contractor who maintains the estate, but the groundsman could not attend until the following morning. The next course of action was to let the Board of Deputies know of the drama taking place at Freemen's Holt, so

he rang Lynn Roffee, the Chair of the Board, who suggested that the Fire Brigade might be the best people to contact.

By this time, it was obvious to Adam that the tree was in danger of falling, possibly across Middleton Street, so he called the Fire Brigade, who, unlike the Council, took the situation seriously. They came down and closed off the road to traffic, and this eventually grabbed the attention of the Council. After all, it was their road being closed. The Fire Brigade commended Adam for his bravery in remaining close to the tree, and it was then that waiting for the sky to fall on his head was perhaps not a good idea. All the residents whose bungalows were in striking distance of the ailing tree were told to find alternative accommodation for their own safety, and my wife and I took temporary residence in a hotel.

Like all trials in life, this one came to a satisfactory end. The Council cut down that part of the tree that was in danger of submitting to the force of gravity that evening, and the remainder of the lime tree was cut down the following day. All that remains is a huge tree stump, so if anyone is curious to know how old the tree was, they can come down and count the rings.

News from the Freemen of England and Wales Association (FEW)

I was pleased to attend the launch of the new book 'The Freemen of Leicester' by Past Master John Tolton in August, a concise summary of past and recent history. Sadly, less than a month later I was sorry to hear that the Gild was closing down – only a few months short of its 50th anniversary since being formed, and despite regular ceremonies admitting new Freemen. Only a few years ago as the South Midlands Area Warden with three Freemen's Guilds and three Courts Leet in my Area, I thought, to use a boxing analogy, that Leicester Gild 'punched above its weight' in organising events such as the national FEW AGM in Leicester in 2007 including a visit to the National Space Centre organised by the late Roger Allen, and also the two-coach trip to the Tower of London organised by Mick Ayres – who was the only Gild rep to send regular reports to the FEW Journal – as I had to draft the rest myself.

Recent activities by other Guilds and Courts Leet in the South Midlands Area include:

Coventry Freemen's Guild

On 9th August at a Guild dinner we were pleased to welcome the new Lord Mayor of Coventry, Cllr Rachel Lancaster as Guild President for her year of office, and she was supportive of our efforts to ensure more Council job applicants take up the option on completing their apprenticeship to become Freemen and join the Guild. She also agreed that as many local nurse roles now need a degree, that this could be worth pursuing with the NHS Training Authority in order to qualify for the Freedom in due course.

Work continues on updating the Guild's website, to complement the Guild's publicity leaflet now in local libraries and museums, and also public facing Council Offices.

The Guild's Christmas Dinner will be on Saturday 13th December at the Hearsall Golf Club at 33 Beechwood Avenue in Coventry, CV5 6DF. There is a choice of menu, and we would welcome any Leicester Freemen to join us. Contact Guild Clerk Anthony Archer on anthon.aa@hotmail.com for more details before December 1st.

Northampton Freemen's Guild

The Guild continues to support the Town Council at regular events like Oak Apple Day and Remembrance Sunday parades. There is concern that facilities for Trustee meetings may be lost due to planned sales of parts of the Guildhall. Better news is that a lunch meeting is scheduled for 25th October – a welcome return to social activities since the Covid pandemic.

Henley-in-Arden Court Leet

Court appointed 'Brook Lookers' have the task of ensuring the River Alne boundaries are secure, and that the river's flow is unobstructed – this led to activity in July to uproot the invasive non-native plant Himalayan balsam that causes soil erosion and crowds out native species.

Warwick Court Leet

After the 12th June Charity Beer festival, the free August Warwick Classic Car Show in the Market Place attracted some notable cars for the many spectators. Court members received awards recently for their continued support of the medieval Lord Leycester Hospital, originally built as the Warwick Guildhall.
