On the 19th of May I was invited to attend the swearing in of the Leicester Council, and the new Lord Mayor, Councillor George Cole. Councillor Cole is the city's 1st Black African Caribbean Lord Mayor. Born in Kingston Jamaica Councillor Cole came to England in

1964. Councillor Cole represents the Western Ward.

On the 7th of May, myself and Chris along with Michael Ayres and Jean attended the Coventry Banquet at Coombe Abbey. It was nice to see old friends. As Platinum Jubilee celebrations started, on the 2nd of June, myself and Malcolm were invited by the Lord Lieutenant and Bishop Martyn to attend the Platinum Jubilee Service at St. Mary de Castro. A little later than normal but importantly, despite the rain, the Gild successfully hosted a number of events over the annual Banquet weekend. The different events give a wonderful opportunity to join together and share in each other's company. This year, on the 17th June the pre-banquet fish & chip supper gettogether witnessed an informal fun evening at the Freemen's Holt. The food was delicious and plentiful and the bingo and quiz that followed was well received by all attendees. Thanks go to Fiona and Russ for running the Bingo and Quiz.

The following evening the more formal Banquet Dinner was hosted at the Leicestershire County Cricket Club, Charles Palmer Suite. It was wonderful to be able to host this event, especially in light of ongoing logistical nightmares from the knock on effect of Covid still around. Those that were able, took the opportunity to attend in their finery, raise a glass and enjoy their choice of menu and silver-service to the table. The new venue appears to have received a positive response, with a number of guests taking the time to send in their thanks and portray their enjoyment of the evening. Owing to Covid the Lord Lieutenant Michael Kapur OBE helped out by giving a very interesting extended talk. I particularly liked his referencing to the beheading of one of the 35 previous Lord Lieutenants. Makes you think!!! We also had a lovely young lady who entertained us with popular songs. I mention these things as I was able to shorten my speech, much to everybody's delight. Just shows you!!!

The Freemen's Church Service and Parade was held on the following Sunday at St. Andrews Church, Aylestone. The Service was a lovely personal affair, led by Rector, Rowena with Colonel Robert Martin, the Gild Patron reading one of the lessons. The Lord Mayor, as our President during his year of office, read the 2nd reading. Part of the service detailed by Rowena referenced the input of the Freemen in the structure of how Leicester was managed before the introduction of the Council. The Lord Mayor, Councillor George Cole, and indeed his wife and daughter advised that after 50 years of living in Leicester he had learnt something new of its historical background! Refreshments were served in the Holt Community Centre after the Service where people lingered and enjoyed each other's company and took advantage of the nice weather for further photo opportunities.

Following tradition, on Friday 24th June the Lord Mayor invited the Gild of Freemen to process with him from the Town Hall to O'Neills Public House in Loseby Lane for the Damask Rose Ceremony. Myself, Malcolm Ballard, Sue Freemen, Lynn Roffee, and Peter Bates were ably led by Chris Rhodes the Mace Bearer.

Saturday 25 June saw Leicester host the Armed Forces Day parade and service. The Gild were invited to robe and myself, Malcolm Ballard, Sue Freemen and Peter Bates were able to represent the Gild at this important event and show appreciation for the armed forces with a dash of pomp and splendour. The parade was led by the pipes and drums of the Seaforth Highlanders, the 400-strong parade of service personnel, veterans, reservists and cadets started off from Jubilee Square marching along the High Street, Gallowtree Gate and Horsefair Street, in the city centre, before making its way to Green Dragon Square. The whole event was very special to be part of and being in the open air

made it additionally poignant and memorable. The Royal Anglians led the Service by placing their drums and 2 crossed flags to represent the altar as would be on a battlefield before the conflict. I find the Drumhead Service very moving. The Cottesmore Wives Choir sang 2 songs albeit pre-recorded. Altogether a lovely service.

In relation to further dates for the diary, thank you to those investigating and contributing to the programme of events for members to enjoy. There are a couple of interesting upcoming events to finalise and advertise, one being the annual visit to the pantomime at the Little Theatre. This year's performance being Aladdin. 34 tickets have been reserved at discounted prices, valid as long as we meet the ticket reserve. Details have been submitted for inclusion into the August copy of GHN. It is hoped attendance numbers will be back to normal years at this popular event, especially as we can start advertising with plenty of time. The 2022 Garden Party

The prime objective of the Party is for it to be a social event for all Leicester Freemen and their families and secondary to raise money for a nominated charity.

Well, I feel that both were more than achieved with so many people enjoying themselves, meeting friends they had not been able to meet since before the pandemic, basking in the sunshine and raising a final total of £860 for the nominated charity which this year was "Against Breast Cancer".

I feel very grateful and proud of my quite small team who worked very hard to organise and stage the event overcoming many trials and tribulations along the way.

We introduced two major organisation changes this year, the one-way system for entry and exit of the main parking area which was self-controlled negating the use of having people with stop/go boards and the new ticket system, meaning applications for tickets were received by telephone or Email and tickets were given on arrival at the event. This latter change saved both money and effort for the applicants and the office.

Of general interest some 350 persons attended and we parked approximately 100 cars.

We can report that on the day no complaints were received, no one sustained any injuries necessitating the use of the first aiders, no children were lost and no one or car, ended up in the river.

The Punch and Judy show was very well received with at times quite a senior audience. The Flea Circus was also a great success despite most youngsters being unaware of what is a flea. I'd been assured in the morning that the performers had all been fed but personally they came up to scratch.

To organise the event the team had to work through a twenty-two item "To do list", and will now meet for the last time this year to work through a "Done list", this will prepare the way for the next Garden Party in 2024.

So, my thanks to the team, and as they used to say in music hall days, "and mainly yourselves" for making the Garden Party a success.

A Freeman Remembered

Thomas Bottoms, a Freeman, was born in Leicester in 1878 and worked as a shoe clicker. He was married to Mary Ann and they had three children, Thomas Harold who was the eldest, James William and Albert Roland who was the youngest. The 1901 and 1911 Census show the family residing at 144 Surrey Street, Leicester.

Thomas Harold, whom I shall refer to as Tommy, was born in 1898 and enlisted as Private 1985, 1/4th Battalion, Leicestershire Regiment on 22 April 1914. He stated on his enlistment papers that he was 17 years and 8 months old. However, he would not turn 16 until the summer that year. When Tommy enlisted, he was working as a foundry hand at Richards Iron Foundry in Martin Street, Leicester.

Tommy's first theatre of war was in France and he arrived there on 2nd March 1915 aged 16. Sadly, Tommy was killed on the 13th October that year at the Hohenzollern Redoubt in France. He was only 17 years old.

Captain John Milne (who later after the war became Field Marshall Lord Milne), also in the same Regiment, wrote a book that recounted "the deeds and actions" of the 1/4th Leicestershire Regiment. Milne said it was "written primarily for those who served or whose relatives served in the battalion". He describes the battalion being in the trenches all morning, and by lunch time smoke and gas had been started by the battalion in the hope that the Germans in the "trenches opposite would be asphyxiated or fly, and the rum was issued joyfully, lots of it". At the time of the planned assault by the battalion Milne wrote "up they come, over they go, forward to their objectives: no one falters, the position must be taken at all costs". Records show that 1/4th Battalion, Leicestershire Regiment lost 20 officers and 454 other ranks that day. Tommy was one of those other ranks. He has no known grave but is remembered on the Loos Memorial, Pas de Calais, France.

James doesn't appear to have taken his freedom but Albert did in 1947. Albert appears to be the last person with the surname of Bottoms to take his freedom in the Freemen Registers up until 1996.

Thomas Snr went to live at No.17 Freemen's Holt in November 1968 and was that bungalow's first resident.


As the Leicester Gild have not elected a FEW Representative since Mick Ayres retired at the 2016 Common Hall meeting, I have been asked to look after that role for the time being, as an Associate Member of the Gild. I am also the FEW Warden for the South Midlands Area which includes Leicester, Coventry, and Northampton Freemans Guilds, and also the Courts Leet of Alcester, Henley-in Arden, and Warwick.

I should explain that the FEW Representative is the link between the Association and individual Guilds or Courts Leet, and key role is to represent them at FEW Court meetings and AGM's, and vote on their behalf.

For Leicester Freemen not familiar with FEW, a very brief history shows:

- Formed in 1966 as the Freemen of England Association, after the Founder President Harry Ward had visited 58 towns to encourage sons of hereditary Freemen to take up their Freedom and join, or form, a Guild for fellowship and to guard their legal rights and customs.
- The Association was critically tested in 1972, when a proposed Local Government Act made no provision for the ongoing rights and continuation of Freemen. FEW action led to this omission being rectified, before the Act was passed into law
- In 1992 the Associations name was changed to include Wales hence 'FEW' for easy reference.
- FEW has no regulatory role, only as a forum for discussion and advice on matters of common interest.
- A legal fund is held to help resolve matters where, for example, local councils try to usurp Freemen's rights.
- The Association holds a Court meeting, comprising Guild representative, Area Wardens, and the Executive committee, normally in March, followed by the AGM in September or October. Both Court and AGM's are normally held at the invitation of member Guilds. The most recent Court Meeting was held at the Leicester Holt facility on 29th March 2022. Leicester has hosted two AGM's so far, in 1993 and 2007. The FEW Honorary Secretary Lee Hensley has recently advised that the 2022 AGM will be held on-line by means of the 'Zoom' platform on 17th September.

The Birth of the Gild of Freemen of the City of Leicester (Part 2)

In my previous article I described the events that led to the creation of the Gild on the 13th January 1976, but that was not the only significant change to the affairs of the freemen in that year. Legal opinion had been sought about the eligibility of those wishing to take up their freedom which at the time involved the father being a freeman before the applicant son was born. The opinion was that in the present society it was reasonable to expect that the son could be born before the father was 21 (the earliest age that a father could become a freeman) and that the male entitlement should include any direct male descendent. As a result of the City Attorney conceding the opinion to be correct there were over 50 new applications for freemen duly sworn in that year.

At the same time that the legal opinion was accepted by the City Attorney it was agreed that the legal age for becoming a freeman should be reduced to 18 from 21 and that the boundary whereby freemen could receive benefit from the charity or become a member of the Board of Deputies should be extended from the City boundary to include the whole of the county.

The newly formed Gild of Freemen grew from strength to strength in both numbers and in activities. By the time of the next meeting held in May at the Empire Hotel on Fosse Road the membership had increased to 126 and at that meeting the Gild welcomed the founder of the Freemen of England, Mr Harry Ward, who gave a talk about the formation of the Freemen of England and about the reasons behind its conception. The legal opinion leading to freemen being sworn in through the direct male line missing out generations came via the Freemen of England. Of that number of 126 one lived in New Zealand and another in South Africa. Towards the end of the year the first General Meeting was held to formalise the Gild and its rules and to elect a Gild Court to replace the voluntary working committee

At that meeting the following Gildsmen were elected to serve on the Gild Court: -

Master of the Gild - Mr R L Langton - Mr H E Dudgeon Deputy Master Clerk - Mr G R Agar - Mr M E Ayres Chamberlain Warden - Mr M H Ayres Warden - Mr A Kellett Warden - Mr P H Kellett Warden - Mr D J Dalby - Mr A Chawner Warden

1977 was the second year in the life of the Gild and changes were taking place. The Lord Mayor of Leicester, Councillor Bert Baker accepted our invitation to become the first President of the Gild during his term of office, an invitation that has continued with all successive Lord Mayors to this day. There were two social dances held that year, both at the Glen Hall on Hillsborough Road, to raise funds for the Gild but the highlight of the year was a visit to Chester at the invitation of the Chester Guild of Freemen. This event proved so popular that two coaches were necessary to take our members and their families. We were made extremely welcome by the Chester Freemen starting the day's programme with a reception in the Town Hall at the invitation of the Lord Mayor and her consort followed by lunch at the Guildhall just a short walk from the Town Hall. After lunch we had a choice of a guided walk around the city, a visit to Chester races, or just do as we please. By the time that we returned to Leicester late in the evening we were all well and truly tired out but full of memories of the day and looking forward to a return invitation to the Chester freemen to visit the Holt.

The following year, 1978, also proved to be an eventful year. Common Hall was held in January in the council chamber at the Town Hall presided over by the Lord Mayor, Councillor Bert Baker

who had kindly offered the council chamber for our use. Common Hall was the term used to describe the meetings of the Merchant Gild in medieval times and was adopted by the Gild of Freemen to describe our annual general meeting. Over 60 Gild members attended that very first Common Hall held at the Town Hall. At that meeting a sample of the proposed armorial bearings was presented to the Gild members for approval and was adopted which led to the production of ties, car badges and other items for sale.

The whole of the year was busy a church service at the Cathedral attended by nearly 80 freemen and their families, another dance and social evening, a barbecue with a licenced bar at the Holt in Aylestone and a trip to York at the invitation of the Freemen of York. Finally, a Christmas party for the children and grandchildren of the Gild members including a visit from Father Christmas with a present for every child, providing that they were well behaved. The last event was perhaps the most tiring of the year, but one that really bought members together.

Until this year prospective freemen have always attended as individuals before the Lord Mayor to be sworn in as a Freeman of Leicester, but because of the number of those wishing to take up the freedom the City Council suggested a more formal ceremony take place with a group of new freemen. On the 3rd November the first enrolment ceremony took place for 26 new freemen presided over by the Lord Mayor, Councillor Albert Watson, who some of you may remember was the Lord Mayor whose chosen charity was the purchase of a scanner for the Royal Infirmary. An appeal that caught the imagination of the whole population of Leicester and the county.

By the end of the decade, just four years after the Gilds conception, we had a thriving organisation providing a means by which freemen could meet each other socially and we had exceeded our expectations with regard to our association with the City Council. Without the hard work and effort of the members of the Gild Court none of this would have succeeded and it is gratifying to look back and see as a team what we achieved, but it was not just the Court, the success also depended on the support of the members. 
